- Boale, Wood & Company Ltd. shall be discharged and released from its duties as Monitor in relation to the Petitioners and these proceedings.

Paragraphs 26 – 33 of the CCAA Order, shall continue to apply, save and except that
the "Administration Charge", defined in paragraph 28 of the CCAA Order, shall be varied
to provide that the Administration Charge shall not exceed an aggregate amount of
\$125,000.
