#### TRUSTEE'S PRELIMINARY REPORT TO CREDITORS

#### **BACKGROUND**

Tercon Mining PV Ltd. ("Tercon Mining" or the "Company") was incorporated on November 28, 2005 and operates as a mining services contractor supplying employment services to Falls Mountain Coal Inc. ("Falls Mountain") who operated the Willow Creek mine, a metallurgical coal mine located near Chetwynd, British Columbia. Tercon Mining employed approximately 100 miners and equipment operators at the Willow Creek mine.

On October 20, 2006, Falls Mountain and its related companies filed for, and obtained, protection from their creditors under the *Companies Creditors Arrangement Act* ("CCAA")(hereinafter referred to as the "CCAA proceedings"). At the date of the CCAA filing, Tercon Mining was owed approximately \$8.9 million from Falls Mountain for mining services rendered. As a result of the CCAA proceedings, Tercon Mining had no cash flow and therefore no ability to pay its creditors. Tercon Mining then sought protection from its own creditors by filing a Notice of Intention to Make a Proposal under the *Bankruptcy & Insolvency Act*.

Tercon Mining had entered an interim Coal Mining Services Agreement with Falls Mountain. The parties agreed that should the agreement be terminated, Tercon Mining shall be entitled to payment for all work completed plus a "break fee" of \$4,500,000. The break fee amount is an agreed upon pre-estimate of losses for demobilization and related costs that Tercon Mining would incur in the event of a termination of the contract. The contract has been terminated and Tercon is entitled to the break fee.

As a result of the CCAA proceedings of Falls Mountain, Tercon Mining provided lay off notices to its miners and equipment operators and has retained only minimal employees for security and preservation purposes.

Tercon Mining has advised it is pursuing new mining service contracts in the surrounding areas to enable it to resume its operations.

#### SUMMARY OF PROPOSAL

- The Company has agreed to grant an irrevocable assignment of the proceeds from the CCAA proceedings immediately upon Court Approval of the Plan of Arrangement relating to Falls Mountain. Currently the amount owing from Falls Mountain including the break fee is estimated to be approximately \$13.5 million CAD.
- The Proposal calls for the distribution of the recovered proceeds under the CCAA proceedings is set out in paragraph 6 of the Proposal as follows:
  - o Secured creditors;
  - o Trustee fees and expenses;
  - o Employees wage claims pursuant to Section 136 of the Bankruptcy & Insolvency Act;
  - o Any amounts owing to Canada Revenue Agency subject to demand under Section 224(1.2) of the *Income Tax Act*;
  - o All outstanding preferred claims;
  - All unsecured claims will be paid rateably based on their proof of claim except Tercon Investments Ltd. and Tercon MRC Limited;
  - o Payment of Tercon Investments Ltd.;
  - o Payment of Tercon MRC Ltd.; and
  - o All remaining amounts to the debtor.

#### FINANCIAL POSITION

The Company filed cash flow projections with the Trustee and the Office of the Superintendent of Bankruptcy. The Company has forecast minimal revenues during the restructuring period as the mine is currently shut down pending either a new investor or sale.

The ongoing operations, which include protection of material and equipment, protection of the site and other properties or assets that are in Tercon Mining's control are being funded through unsecured advances from Tercon Investments Ltd., the parent company.

#### **CREDITORS**

#### Secured Creditors

Canadian Western Bank has a registered General Security Agreement dated May 19, 2006. The Company has advised that the Bank has made no advances against the facility and therefore there is no known secured indebtedness.

On November 20, 2006, Tercon Investments Ltd. registered a General Security Agreement as security for all future advances to Tercon Mining. Currently Tercon Mining is indebted in the amount of \$10,000 which Tercon Investments Ltd. is prepared to defer in accordance with the terms of the proposal.

#### **Preferred Creditors**

The Company is indebted to various employees for wages estimated at \$15,000 relating to a safety bonus based on hours worked at an agreed rate. This claim is required to be paid in full upon Court approval of the proposal. There are no other known preferred claims

#### **Unsecured Creditors**

The Company is indebted to various trade creditors listed on the Statement of Affairs. In addition to the trade creditors, Tercon Mining is also indebted to its parent company, Tercon Investments Ltd., and associated sister companies, Tercon Equipment Ltd., Tercon Construction Ltd., and Tercon MRC Ltd. Tercon Investments Ltd. and Tercon MRC have agreed to defer their claim to the unsecured creditors under an accepted proposal. These two Tercon companies are owed approximately \$1.3 million collectively.

#### **Contingent Creditors**

Listed on the Statement of Affairs as Contingent Claims valued as unknown and titled - Various Employees- Severance.

The Company provided lay off notice to its employees as a result of the CCAA proceedings of Falls Mountain. We are advised that by reason of the terms of the collective agreement, laid off employees are subject to recall for a period of 12 months. Employees not recalled by October 24, 2007 may be deemed terminated and entitled to termination pay the amount of which is unknown and contingent upon whether, in the meantime, Tercon Mining recalls its employees

#### ASSETS

The following is a summary of the assets declared by the Company on its Statement of Affairs.

#### Cash on hand

The Company provided to the Trustee at the onset of the proceedings a retainer of \$10,000. These funds are currently held in our trust account. All future cash requirements for operations have been advanced to Tercon Mining by Tercon Investments Ltd. on an unsecured basis.

#### Accounts Receivable

On its Statement of Affairs, the Company declared the value of accounts receivable to be \$13,495,448 and has estimated to collect same. The receivable is comprised of \$8.995 million for mining services provided to Falls Mountain plus a \$4.5 million break fee resulting from the termination of the mining service agreement. This amount has been acknowledged by the Monitor in their Report to the Court in the CCAA proceedings.

Ernst & Young Inc. were named as monitor in the CCAA proceedings of Falls Mountain. We have contacted the Monitor and have been advised as follows:

- Ernst & Young Orenda Corporate Finance Inc. ("EYO") have been appointed to conduct a search for a purchaser or investor for Falls Mountain; and
- Management of Falls Mountain is optimistic that a sale of the mine or restructuring will result in payment in full of all the outstanding Falls Mountain creditor claims;

In the Monitors First Report to the Court dated November 10, 2006, Ernst & Young Inc. advised as follows:

- EYO have entered into confidential agreements with interested parties with respect to the transaction process to facility a sale or restructuring of the mine
- The Monitor anticipates that, based on its review of EYO's proposed transaction
  process timetable and the activities to date, Falls Mountain could be in a position
  to consider proposals from participants in the process as early as the month of
  December.

#### Inventory

On its Statement of Affairs, the Company declared under the category Stock in Trade the book value of the assets of \$112,139 with an estimated value to produce \$15,000. The inventories are primarily stores maintained on site at the mine.

#### **CONSERVATORY MEASURES**

The Company has filed an encumbrance, claiming a lien, against the coal leases comprising the Willow Creek Mine with MEM's Recording Office, Titles Division to protect its position and that of its sub-contractors.

#### CONDUCT OF THE DEBTOR

The Trustee has not had any evidence of the debtor being a party to any preferential payments, settlements or reviewable transactions.

#### REMUNERATION OF TRUSTEE

The Trustee's fees and disbursements will be paid from payments made pursuant to paragraph 3 of the Proposal and will be subject to the approval of the Inspectors, should any be appointed, and taxation by the Court

#### ESTIMATED REALIZATION - BANKRUPTCY VS. PROPOSAL

A Statement of Estimated Realization which compares the amount available to the unsecured creditors in both a bankruptcy and proposal scenario is attached as Schedule A to this report. It is inherent in the Statement of Estimated Realization that the amount owing from Falls Mountain be collected in full.

The schedule reflects that all creditors are estimated to be paid in full. It also reflects in a proposal scenario, that Tercon Investments Ltd. and Tercon MRC have deferred their claims in an amount totalling \$1.3 million. Therefore providing the unsecured creditors greater certainty should the amount collected from Falls Mountain be less than 100 cents on the dollar.

#### TRUSTEE RECOMMENDATION

This is a liquidating proposal that provides creditors with a maximum return, based on the following:

- Receipt of full payment due from Falls Mountain under the CCAA proceedings;
- Deferral of the payment due to Tercon MRC Ltd. and Tercon Investments Ltd. of approximately \$1.3 million dollars which would otherwise rank pari passu with all other unsecured creditors; and
- The funding of the ongoing operational needs on an unsecured basis by the parent company, Tercon Investments Ltd.

Based on the terms of the proposal, the unsecured creditors will be paid in priority to the claims of Tercon Investments Ltd. and Tercon MRC Ltd. As such, should the total

amount of funds received from Falls Mountain be up to \$1.3 million less than anticipated, Tercon Mining's creditors will still be paid in full.

The Trustee recommends that the creditors accept the Proposal as the creditors will be better off under the Proposal than in Bankruptcy.

#### Voting

A meeting of creditors has been scheduled for 11:00 am on December 13, 2006 in the Kent Room, Crowne Plaza- Hotel Georgia, 801 West Georgia Street, Vancouver, BC.

All creditors who have proven their claims prior to the time and date schedule for the first meeting of creditors may vote in favour of accepting the Proposal or vote to refuse the Proposal. In order for the Proposal to be accepted at least 66 2/3 % in dollar value and 50% plus one in number of voting creditors must vote in favour of the Proposal. The proposal must also be approved by the Court.

If the creditors do not approve the Proposal, Tercon Mining will be deemed to have made an assignment in bankruptcy.

#### PROPOSAL

Tercon Mining PV Ltd., the above-named debtor, submits the following Proposal pursuant to the provisions of Part III, Division I of the *Bankruptcy and Insolvency Act*, R.S.C. 1985, Chapter B-3 as amended:

#### **DEFINITIONS**

CCAA Proceedings means the proceedings under the Companies Creditors Arrangement Act commenced in the Supreme Court of British Columbia, Action No. S066791 by Pine Valley Mining Corporation, Falls Mountain Coal Inc., Pine Valley Coal Inc. and Globaltex Gold Mining Corporation

Monitor means the Monitor appointed in the CCAA proceedings.

proceeds means the amount recovered by Tercon Mining PV Ltd. in respect of the indebtedness to it of Falls Mountain Coal Inc. which recovery is a result of a disposition of the *Assets* approved by the Court in the CCAA proceedings.

Assets means the assets of Falls Mountain Coal Inc. and the shares in that corporation held by Pine Valley Mining Corporation.

recovered proceeds means the amount recovered by Tercon Mining PV Ltd. from the CCAA proceedings.

initial filing means the filing on October 24, 2006 by Tercon Mining PV Ltd. of a Notice of Intention to file a Proposal

#### TERMS OF PROPOSAL

- 1. Subject to the provisions hereof, all unsecured creditors shall be paid rateably from the *recovered proceeds* within 15 days the same are recovered.
- 2. Payment may be made by the debtor to secured creditors, or secured creditors may realize on assets held by the debtor, in accordance with the terms of the applicable hypothecation, mortgage, security agreement or other instrument of security as provided for by the *Bankruptcy* & *Insolvency Act* ("the *Act*").
- 3. All proper fees and expenses of the Trustee relating to the commencement of this proceeding and the preparation and implementation of this Proposal shall be paid in priority to the claims of all creditors of the debtor.
- 4. The debtor will, upon Court Approval of a Plan of Arrangement in the *CCAA Proceedings*, grant the Trustee an irrevocable assignment of the proceeds to be distributed under this Proposal and shall provide notice to the *Monitor*:
- 5. The unsecured creditors on acceptance and Court Approval of this Proposal shall have agreed to accept payment to them hereunder in full settlement and satisfaction of their claims provable against the debtor under the provisions of the *Act*.
- 6. The recovered proceeds shall be distributed by the Trustee in accordance with the following priorities:
  - (1) in payment of any secured creditors;
  - (2) in payment of the proper fees and expenses of the Trustee;
  - (3) in payment of such employees and former employees (if any), immediately after Court Approval of the Proposal, of amounts (if any) equal to the amounts they would be qualified to receive under para 136 1(d) of the *Act* if the debtor had become bankrupt on the date of the *initial filing* as well as any wages, salaries or

- compensation for services rendered (if any) after that date and before Court approval of the Proposal;
- (4) in payment of any amounts outstanding as of the *initial filing* which amounts could be subject to a demand under subsection 224(1.2) of the *Income Tax Act* of Canada or under any substantially similar provisions of provincial legislation;
- (5) in payment of any preferred claims not previously referred to which shall be paid without interest;
- (6) in payment of unsecured creditors rateably, except Tercon Investments Ltd. and Tercon MRC Limited;
- (7) in payment of the unsecured claim of Tercon Investments Ltd.;
- (8) in payment of the unsecured claim of Tercon MRC Limited;
- (9) the amount remaining shall be paid to the debtor;
- 7. During the term of this Proposal the debtor shall file its GST and corporate income tax returns and pay all tax in accordance with applicable legislation.
- 8. Her Majesty the Queen in Right of Canada shall agree to take no action to enforce any security interest or deemed trust arising against the debtor's property as a result of the debtor's non-compliance prior to the initial filing with obligations under the *Income Tax Act* of Canada, the *Excise Tax Act* of Canada, the *Employment Insurance Act* of Canada and/or the Canada Pension Plan and to release any such security interest or deemed trust upon performance of this Proposal.
- 9. On acceptance and Court Approval of this Proposal, any claims which may exist against Directors of the debtor relating to statutorily imposed liabilities for the obligations of the debtor within section 50.1(13) of the *Act* shall be released.

- 10. Boale, Wood & Company Ltd., Trustee in Bankruptcy, of Vancouver, British Columia (represented by Stephen A. Boale C.I.R.P.) shall be the Trustee acting under this Proposal and the recovered proceeds shall be paid to the Trustee for distribution in accordance with the terms hereof.
- 11. The creditors may appoint up to five Inspectors who will assist and advise the Trustee and who will have the right to grant extension of time for any payment or action that is hereby required provided that they consider such relief to the debtor to be in the best interest of the creditors and who may also approve payment to the Trustee of advances on its remuneration.
- 12. The Trustee and Inspectors shall be exempt from all personal liability in fulfilling any duties or exercising any powers conferred upon them by this Proposal, or generally in the carrying out of the terms of this Proposal and each of them shall be liable only for any wilful and wrongful act, default or neglect.
- 13. The debtor in continuing to carry on business and in seeking to secure and carry out contracts as may be advantageous shall pay all claims arising after the date of the initial filing in full with funds other than those funds dedicated to fulfilment of this Proposal (but including funds referred to para 6(9) hereof ("dedicated funds"). Any security given by the debtor to obtain financing with which to continue business shall exempt the dedicated funds.
- 14. Tercon Investments Ltd. and Tercon MRC Limited hereby agree to postpone their claims as set forth in para 6 hereof.
