AND IT APPEARING to the Court that the following act of bankruptcy has been committed;


677673 B.C. Ltd. has allowed a Writ of Execution issued against it to be returned by the Bailiff endorsed to the effect he could not locate any property to take;

THE COURT HEREBY ORDERS THAT:


1. 677673 B.C. Ltd, of 900 – 550 Victoria Street, Prince George, BC, is hereby adjudged bankrupt;
