**AFFIDAVIT**

I, GERALD BASIL PARFENUIK, retired, of #103 -01148 Heffley Crescent, Coquitlam, British Columbia, SWEAR THAT:

1. I am a preferred shareholder of All Canadian Investment Corporation ("**ACIC**"), and as such I have personal knowledge of the matters and facts deposed to in this Affidavit save and except where same are stated to be based upon information and belief, and where so stated, I verily believe them to be true.
2. I am the owner of 25 preferred shares in ACIC. My wife, Angela Parfenuik ("**Angela**"), is the owner of 85 preferred shares in ACIC.
3. Angela filed share redemptions with ACIC for all her shares in June 2015. I filed share redemptions with ACIC for all my shares in September 2015.

4. Given that we are likely to lose of a substantial portion of our \$110,000 investment that we relied on as part of our retirement, Angela and I are unwilling to invest further funds into the ACIC matter. I am currently 73 years old and my primary concern financially is that Angela is able to maintain a comfortable quality of life should I pass away, and we are not able to do so if we have to spend money on legal fees.
5. Angela and I want to remain involved in the process and ensure maximization of return of shareholder funds from ACIC. I have been in attendance at all hearings in this matter since September 2018. I attended these hearings with other ACIC preferred shareholders that I knew, including Hank Andresen ("**Hank**").
6. In November 2018, Mr. Justice Walker gave permission for Hank and I to email other preferred shareholders through Boale, Wood & Company Ltd. (the "**Monitor**").
7. On November 29, 2018, Hank and I provided a letter that we had written to the Monitor, to send to other shareholders and seek their support for a more proactive involvement by preferred shareholders in the CCAA proceedings (the "**November Letter**"). On or around December 7, 2018, the Monitor sent the November Letter to preferred shareholders. Attached and marked as **Exhibit "A"** to this affidavit is a true copy of a December 7, 2018 letter from the Monitor to all preferred shareholders enclosing a copy of the November Letter.
8. Later in December 2018, Hank and I provided another letter to the Monitor to send to shareholders who had not responded to the November Letter (the "**December Letter**"). The monitor provided a copy of the December Letter to

shareholders on or around January 4, 2019. Attached and marked as **Exhibit "B"** to this affidavit is a true copy of the December Letter.

9. In response to the November Letter and the December Letter, we received a substantial number of email responses from preferred shareholders interested that we understood were interested in pro-active involvement in maximizing the recovery of our investments. We referred to these individuals as "ACIC Pro Active Preferred Shareholders", or "PAPS".
10. We also received some emails from preferred shareholders who advised us that they did not necessarily support a pro-active approach, but wanted us to keep them informed.
11. Several individuals advised us that they held valid power of attorneys for a shareholder, which we accepted without question.
12. Hank followed up by telephone whenever a shareholder contacted us, and advised me by email if the individual should be considered a Pro Active Preferred Shareholder.
13. Based on emails from shareholders and confirmation emails from Hank, I maintained a Microsoft Excel worksheet of all preferred shareholders that supported in our proactive approach. Attached and marked as **Exhibit "C"** to this affidavit is a true copy of the current database of ACIC Pro Active Preferred Shareholders.
14. Once we had the support of approximately 300 preferred shareholders, Hank and I decided to approach law firms to assist us with our goal of pursuing full recovery of investments for all ACIC preferred shareholders. During these consultations,

Linda and Mike Riesterer (“Linda” and “Mike”, respectively) became involved in discussions as well.

15. Eventually, Hank, Linda, Mike and I decided to retain Lakes, Whyte LLP to represent the interests of ACIC preferred shareholders in the CCAA proceedings. During discussions regarding retaining Lakes, Whyte LLP, I became concerned that I would be personally obligated for any legal fees incurred in the matter.
16. After discussing the matter with Angela, I declined to sign a retainer agreement with Lakes, Whyte LLP, because I want to ensure that I do not incur further debt so that my wife is able to continue financially supporting herself once I pass away. While Angela and I are both interested in remaining involved in the process and pursuing any available recovery, we cannot do that if we are required to financially contribute to the legal funding.
17. We support a solution where legal costs are shared by preferred shareholders collectively, such as funds collectively earmarked for distribution to preferred shareholders being used to fund legal counsel on our behalf, but are unable to add new money to fund counsel.



Dear ACIC Preferred Shareholders

In the past few weeks several preferred shareholders have attended court hearings related to ACIC. It is apparent that the preferred shareholders need to have a more direct involvement in the proceedings in order to achieve maximum return of invested funds.

In particular, Mr. Bergman, President ACIC, has been cited in court with "wrongful misconduct". Examples are:

- 1) Lending investor funds using unsecured promissory notes (instead of mortgages!), totalling more than \$20,000,000;
- 2) High percentage of the invested funds loaned to one Borrower, unsecured;
- 3) Loans to long time friends being forgiven;
- 4) using investor funds to purchase shares in Howe Street start-up corporations;
- 5) Loans to staff, investors and other improper persons.

Based on this information, a "civil suit" by the us the preferred shareholders, is a strong probability.

To help us achieve maximization of return of shareholder funds through more direct involvement, the Court (Judge Walker) gave us permission to contact all ACIC preferred shareholders through the "Monitor", John McEwon of Boale Wood. This action is proper as it protects the privacy of the investor. It is now your decision to identify yourself.

Dear ACIC preferred shareholders,

It has been less than one month since our first communication to you through the Monitor. We asked the shareholders to write us if they wanted to become more proactive in the return of their invested funds. Our first email gave you some information about Mr. Bergman and others involved in the disappearance of all the ACIC preferred shareholder investor funds. Seventy five percent of loans were to one borrower. Many loans were given without real estate registered security. Our Invested funds were given to a start-up company. Repayment of a loan was forgiven in exchange for 10% in a venture and held by a company owned by Mr. Bergman. The court called these examples "wrongful misconduct"; we call it fraud.

The Monitor will be liquidating all assets that are known or available to him due to either mortgage security or personal guarantees. Our proposed action is different. We are proposing action against the parties where wrongful misconduct is apparent. This will involve legal expenses. This is the reason for an appeal for more preferred shareholders.

As of January 3rd, 230 of the 650 preferred shareholders have agreed to become more proactive. These represent approximately 50% of the invested total of \$37.5 million. Everyone has been contacted by telephone or email.


