C-36 as amended (the "CCAA"), the British Columbia Supreme Court Civil Rules and the inherent jurisdiction of this Honourable Court;

THIS COURT ORDERS AND DIRECTS THAT:


1. Terms and expressions not defined in this Order shall have the meanings attributed to them in the Order of this Court pronounced on November 10, 2017 (as varied from time to time, the "Initial Order").

2. The time for service of the Notice of Application dated November 4, 2019 and supporting materials is abridged such that the application is properly returnable on Wednesday, November 6, 2019 and service upon any interested party other than those parties on the service list maintained by the Petitioner and the Monitor in this matter is hereby dispensed with.
3. Paragraph 3(a) of the Order pronounced September 11, 2019 is hereby varied to provide as follows:

“the Contract of Purchase and Sale for Commercial Real Estate dated October 21, 2019 between Altezza Properties Ltd. and for the Altezza Lands is unconditional; and”
4. The Honourable Mr. Justice Walker is hereby seized of the following proceedings:
 - a. Action # S1910894, All Canadian Investment Corporation v. Michael Adrian Lensen, Vancouver Registry;
 - b. Action # S1910871, All Canadian Investment Corporation v. Meridian Resource Accommodations Inc., Vancouver Registry;
 - c. Action # S1910895, All Canadian Investment Corporation v. Wayne and Barb Blair, Vancouver Registry;
 - d. Action # S1910893, All Canadian Investment Corporation v. Robert Frederick and Catherine Frederick, Vancouver Registry; and
 - e. Action # S1910892, All Canadian Investment Corporation v. Ronald Weninger, also known as Ron Weninger and Elfrieda Weninger, Vancouver Registry.
5. The proceedings are adjourned to Wednesday November 18, 2019 at 10:00 AM, for a one (1) day hearing before Mr. Justice Walker.
6. The Petitioner is directed to file application materials, for hearing November 18, 2019, for approval of a Claims Process Order, a Meeting Process Order and related matters.
7. Lakes, Whyte LLP is directed to file application materials, for hearing November 18, 2019, for leave to commence a derivative action, or such related relief as it intends to seek.
8. Except as provided herein, all the relief provided in the Initial Order, as amended from time to time, is hereby confirmed and extended and the stay of proceedings is hereby extended to February 6, 2020.

9. The approval of counsel as to form listed in Schedule "A" hereto, except for counsel for the Petitioner, is hereby dispensed with.
